- (x) Defendant Vanvacter (03) charged in counts 1, 10, 22 of a 40 Count indictment
- (x) Defendant Gonzalez (04) charged in counts 1, 6, 16,25 and 34 of a 40 Count indictment
- (x) Defendant Gonzalez (06) charged in counts 1 of a Count indictment
