ORDER OF DETENTION

This matter came before the Court on October 1, 2012 for a removal and detention hearing. The government was represented by Assistant U.S. Attorney William Otteson. The defendant was present and represented by Assistant Federal Defender Reggie Aligada.

The defendant knowingly and voluntarily waived the removal portion of the hearing, and admitted that he is the defendant named in the Superseding Indictment issued by the grand jury in the Western District of Missouri.

Regarding detention, the Court and the parties had available to them the Report of Pretrial Services which recommended detention. The government also supplied Exhibit 1, without objection by the defendant, which was a printout of the defendant's prior law enforcement encounters with the U.S. Immigration & Customs Enforcement ("ICE"). Based upon that record and the arguments presented, the Court concluded that there was no condition or combination of conditions that could reasonably assure the defendant's appearance in court.

#### FINDINGS OF FACT

The defendant is a citizen of Mexico and an illegal alien who at the time of his arrest was living with his girlfriend in Owatonna, Minnesota. He has substantial family ties to Mexico. He has no family ties to Minnesota or Missouri, the charging district. He is charged with conspiracy to harbor and transport illegal aliens, and is part of a multi-defendant indictment that alleges, among other things, use of counterfeit identifications by illegal aliens. He faces a statutory maximum term of imprisonment of 15 years.

The defendant is currently in immigration removal proceedings. At the commencement of those proceedings in January 2012, he posted a \$10,000 cash bond despite being unemployed. The defendant also had \$420 in cash on his person at the time of his arrest in September 2012. Government Exhibit 1 reflects that, on at least one prior ICE encounter with the defendant at the Mexican border, the defendant used an alias. Government Exhibit 1 also reflects that the defendant in previous ICE encounters has supplied at least three different dates of birth.

#### CONCLUSION OF LAW

Based upon the above findings of fact, the Court concludes by a preponderance of the evidence that no condition or combination of conditions of bond will reasonably assure the defendant's appearance in court. CASE 0:12-mj-00658-TNL Document 8 Filed 10/05/12 Page 3 of 3

Accordingly, IT IS HEREBY ORDERED that:

1. The motion of the United States for detention of defendant is GRANTED;

2. Defendant is committed to the custody of the Attorney General for

confinement in a corrections facility, and shall be separated, to the extent practicable,

from persons awaiting or serving sentences or being held in custody pending appeal;

3. Defendant shall be afforded reasonable opportunity to consult privately

with counsel; and

4. Upon order of a court of the United States or on request of an attorney for

the government, the person in charge of the corrections facility in which the defendant is

confined shall deliver him to the United States Marshal for the purpose of appearance in

connection with a court proceeding.
