## CLERK'S MINUTES

#### FIRST APPEARANCE INDICTMENT AND ARRAIGNMENT

#### Defendants advised:

- 1. Of the charge;
- 2. That he/she is not required to make any statement and that any statement made by him/her may be used against him/her in Court;
- 3. Of his/her right to retain counsel and to request assignment of counsel if he/she is unable to obtain counsel; and
- 4. Of his/her right to bail or, if no bail is set, to a detention hearing to determine if he/she is a flight risk or a danger to persons or the community.

### **BAIL**

- (x) Defendant VANVACTER (17), bond & conditions of release continue as set out on 9/26/12 continue.
- (x) Defendants ORDONEZ-CHANAS (10), HERNANDEZ-FLOREZ (12) AND FELIPE-LOPEZ (13) are remanded to the custody of the U.S. Marshal pursuant to a Detention Order.

#### <u>ARRAIGNMENT</u>

- (x) No changes were made to the charges against defendants ORDONEZ-CHANAS (10) and HERNANDEZ-FLORES (12).
- (x) Defendant FELIPE-LOPEZ(13) waived the formal reading of the superseding indictment.
- (x) The government summarizes the changes made to Count 1 (conspiracy charge).
- (x) The court read the new charges as to defendant FELIPE-LOPEZ (13) (Counts 7, 16, 44 and 45) and VANVACTER (17) (Counts 1, 16, and 44).
- (x) Defendant ORDONEZ-CHANAS (10) charged in Count(s) 1s, 9s-15s, 18s-25s, 27s-33s, 37s-43s of a 45 Count superseding indictment.
- (x) Defendant HERNANDEZ-FLORES (12) charged in Count(s) 1s, 4s, 5s of a 45 Count superseding indictment.
- (x) Defendant FELIPE-LOPEZ (13) charged in Count(s) 1s, 2s-3s, 7s, 8s, 16s-17s, 26s, 35s-36s, 44s, 45s of a 45 Count superseding indictment
- (x) Defendant VANVACTER (17) charged in Count(s) 1, 16, 44 of a 45 Count indictment
- (x) Defendants FELIPE-LOPEZ (13) and VANVACTER (17) informed of the maximum punishment for each applicable count of the superseding indictment.
- (x) Defendants entered a plea of not guilty to each count of the indictment applicable to him/her.

#### **ORDERS**

- (x) Defendants ordered committed back to custody of U.S. Marshal.
- (x) Defendant VANVACTER (17) ordered released on a continuing bail bond.
- (x) Case ordered set for trial on the joint criminal jury trial docket which commences November 26, 2012.
- (x) Scheduling conference to be set at a later time.
