# INDICTMENT

## THE GRAND JURY CHARGES:

That between on or about January 1, 2002, to and including the date of this indictment, said dates being approximate, in the Western District of Missouri and elsewhere, WILLIAM ENEFF, a/k/a "Muff," GARY MICKIEWICZ, a/k/a "New Yorker," BILLIE J. THOMLINSON, a/k/a "Dusty," ROBERT R. PETERS, a/k/a "Possum," TIMOTHY R. DAVIS, MICHAEL FITZWATER, a/k/a "Holms," ROBERT L. MAYS, a/k/a "Goose Rob," DONALD STREET, a/k/a "Donnie," STEVEN M. STREET, a/k/a "Goose Steve," MICHAEL HENSLEY, a/k/a "Joe Poke," and DONALD CULEY, a/k/a "Kooly," defendants herein, did knowingly and intentionally combine, conspire, confederate, and agree with each other and others, both known and unknown to the grand jury, to distribute: (1) a mixture or substance containing a detectable amount of methamphetamine, a Schedule II controlled substance, in an amount of five hundred (500) grams or more; (2) cocaine, a Schedule II controlled substance; and (3) marijuana, a Schedule I controlled substance contrary to the provisions of Title 21, United States Code,

Sections 841(a)(1) and 841(b)(1)(A), all in violation of Title 21, United States Code, Section 846.
