**MR. ZAMORA’S CONCURRENCE IN  
MS. DAVIDSON’S MOTION REQUESTING A CONTINUANCE  
OF THE JURY TRIAL CURRENTLY SET FOR OCTOBER 22, 2012,  
WITH SUPPORTING SUGGESTIONS**

The defendant, Rafael Zamora, by counsel, hereby respectfully concurs in the granting of Ms. Davidson’s motion requesting a continuance of the jury trial currently set for October 22, 2012.

**SUPPORTING SUGGESTIONS**

Mr. Zamora is not being detained. He has been released on bond pending trial.

Mr. Zamora’s motion in limine and request for a hearing, was filed on February 22, 2012 (doc. 399). By order of October 12, 2012, the Court ordered the government to respond to the motion by October, 17, 2012 (doc. 507). The government has now responded (doc. 508) and the ECF notice states that “[r]eply suggestions [are] due by 11/1/2012 unless otherwise directed by the court....”

The government's response is five pages in length with numerous case cites. The time between now and next Monday, the current start date for the trial, does not afford Mr. Zamora sufficient time for my formulating a reply on his behalf and then hopefully having a hearing on the motion.

Ms. Davidson's motion relates that the government does not have any objection to the granting of her motion for a continuance.

Mr. Zamora stipulates to the appropriate Speedy Trial Act language (*see* 18 U.S.C. § 3161(h)) for the continuance.

**WHEREFORE**, Mr. Zamora prays that this Court grant Ms. Davidson's request for a continuance of the jury trial currently set to commence next Monday, October 22, 2012, to the next trial docket commencing in March 2013.
