## INDICTMENT

## THE GRAND JURY CHARGES THAT:

## COUNT ONE

On or between January 1, 2006 and November 17, 2010, said dates being approximate, in the Western District of Missouri and elsewhere, JUAN ANTONIO MARRON, a/k/a "Casper"; DAVID HERNANDEZ-MONTOYA; MARIO MARRON; PETER ADAM FLORES; ROBERT JOSEPH OLVERA; ANTHONY FRANCIS ALVAREZ; BENITO CASTILLO GUTIERREZ; JOHN GASCA, JR.; JASON RICHARDSON; MARCO ANTONIO MURSIA; ARMANDO MENDEZ; DESHAUN LATKEEK CERUTI; MARIA MARRON, a/k/a "Luz"; RAFAEL ZAMORA; JOSEPH MICHAEL LOPEZ; FRANK MICHAEL ALVAREZ; GILBERT

LUPERCIO; MARGOT CHARLENE DAVIDSON, and MUHAMMAD IBRAHIM ROLLIE, defendants herein, did knowingly and intentionally combine, conspire, confederate, and agree with each other and others, both known and unknown to the grand jury, to distribute: (1) five (5) kilograms or more of cocaine, a Schedule II controlled substance; (2) fifty (50) grams or more of cocaine base (a/k/a "crack"), a schedule II controlled substance; and (3) One hundred (100) kilograms or more of marijuana, a Schedule I controlled substance, contrary to the provisions of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(A) and (B), all in violation of Title 21, United States Code, Section 846.

## COUNT TWO

On or between January 1, 2006 and November 17, 2010, in the Western District of Missouri, and other places, JUAN ANTONIO MARRON, a/k/a "Casper"; DAVID HERNANDEZ-MONTOYA; MARIO MARRON; PETER ADAM FLORES; ROBERT JOSEPH OLVERA; ANTHONY FRANCIS ALVAREZ; BENITO CASTILLO GUTIERREZ; JOHN GASCA, JR.; JASON RICHARDSON; MARCO ANTONIO MURSIA; ARMANDO MENDEZ; DESHAUN LATKEEK CERUTI; MARIA MARRON, a/k/a "Luz"; RAFAEL ZAMORA; JOSEPH MICHAEL LOPEZ; FRANK MICHAEL ALVAREZ; GILBERT LUPERCIO; MARGOT CHARLENE DAVIDSON, and MUHAMMAD IBRAHIM ROLLIE, defendants herein, and others, knowing that the property involved in the financial transactions represented the proceeds of some form of unlawful activity, did knowingly and intentionally combine, conspire, confederate and agree with each other and others, both known and unknown to the grand jury, to conduct financial transactions, which in fact involved the proceeds of a specified unlawful activity, to wit: the conspiracy to distribute controlled substances contrary to

the provisions of Title 21, United States Code, Section 841(a)(1) and Title 21, United States Code, Section 846 charged in Count One, with the intent to promote the carrying on of that specified unlawful activity, in that cash obtained from drug sales was then used, in whole or part, to purchase additional drugs for sale, thus promoting the drug conspiracy.

All in violation of Title 18, United States Code, Sections 1956(a)(1)(A)(i) and (h).

# **CRIMINAL FORFEITURE ALLEGATION**

The allegations contained in Count One of this Indictment are re-alleged and incorporated by reference for the purpose of alleging forfeitures pursuant to the provisions of Title 21, United States Code, Sections 853(a)(1), 853(a)(2) and 853(p) and Title 18, United States Code, Section 982(a)(1) and Rule 32.2(a).

As a result of the commission of the violations charged in Count One of this Indictment, JUAN ANTONIO MARRON, a/k/a "Casper"; DAVID HERNANDEZ-MONTOYA; MARIO MARRON, DESHAUN LATKEEK CERUTI; MARIA MARRON, a/k/a "Luz"; RAFAEL ZAMORA; JOSEPH MICHAEL LOPEZ, JASON RICHARDSON, and GILBERT LUPERCIO, defendants herein, shall forfeit to the United States, pursuant to Title 21, United States Code, Section 853, any and all property constituting or derived from any proceeds that the defendants obtained directly or indirectly as a result of the violations charged in Count One and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of the violations alleged in Count One of this indictment, including but not limited to the following:

- (2) has been transferred or sold to or deposited with, a third person;
- (3) has been placed beyond the jurisdiction of the Court;
- (4) has been substantially diminished in value; or

(5) has been commingled with other property which cannot be subdivided without difficulty;

it is the intention of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek forfeiture of any other property of said defendants up to the value of the above-described forfeitable property, all in violation of Title 21, United States Code, Sections 841 and 853, including but not limited to any of the above listed property or other property located subsequently in which any defendant has an ownership interest.
