I am writing this letter to you for a lot of reasons. First off I'm writing because I'm upset I haven't heard from my Lawyer Susan Hunt in over 4 months. Last time I talked to or seen her was about mid or late June. I've tried calling and calling and I can never get thru to her on any of the numbers I have for her. In the time I did talk to her last I had asked her for more information relating to my case and she said she was gonna send me some and I have yet to receive any. It'll be a year the 19<sup>th</sup> of November since I've been here in CCA, and out of that year I've only been visited by her twice maybe three times. I've asked her for evidence on my case, I've asked her for wiretap warrants, I've asked her for anything that I can look over and know what's going on with my case. I was told by her that our trial date was scheduled for mid September. So I've been here worried, and stressing out thinking I'm still going to court in September. And I come to find out it got pushed back to March. She did not advise me of this, I had to hear it from somebody on the outside. I've also asked her to let me know why some of my co-defendants are even involved in this case. A lot of my co-defendants don't even know each other. I don't know two of them, Muhammad Ibrahim Rollie and Margot Charlene Davidson. I also wanted to ask you judge why a car of mine that I bought back in '97 was confiscated. I bought that car 9 years before I was supposedly under investigation. Not only that, it was taken the same day that everything else was confiscated but it is not listed in the Forfeiture Allegation list I have. Everything else that got confiscated was returned by the way, except that car. It's like it just mysteriously disappeared. I would like to know

where that vehicle is please. It's a 1964 chevrolet Impala. I have been kept in the dark about my case by Mrs. Susan Hunt. She is not helping my in anyway. My other Co-defendants Lawyers have sent Legal mail to their clients at least letting them know what's going on. I haven't recieved anything from her. When I last spoke to her she told me she had alot of discovery to look over and fill me in. It's been almost a year and she has yet to explain anything about it to me. Phone calls that are suppose to be incriminating, have yet to be presented to me. I'm still very confused about all this. I really have no idea what's going on. My life is in the hands of this woman to help me and I feel that she has not done anything to help. Everyday phone calls that I had with friends and family are somehow interpreted into wrong doing I hear. Who's interpreting these calls? I don't know! That's something I've been trying to ask and talk to my lawyer about. I feel I need another lawyer appointed to me. I've been waiting too long for Susan Hunt hoping that maybe she will contact me, but that's not happening. Time is running out for me and I need to be ready or at least informed on what's ahead of me. Also on my detention order, it is said I used several alias, I have never in my life had to use another name. If I had don't you think it would of come up in the arrest ~~at~~ the time of fingerprinting. I don't see why I couldn't get bond to be with my wife and kids until my sentence day. I Hope you take my letter in consideration on my lawyers actions on my case. With all respect your honor. THANK YOU.

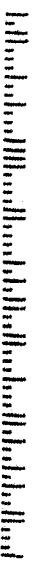
