DEAR SIR:

THIS LETTER IS A REQUEST FOR A DIFFERENT COURT APPOINTED ATTORNEY. RON HALL SEEMS TO BE BORED & NOT INTERESTED IN PLEADING FOR ME. I HAVE MADE THREE CALLS TO HIM THIS PAST MONTH. TWICE WE SPOKE & HE SAID HE WOULD GET BACK WITH ME. THE THIRD CALL I GOT HIS VOICE MAIL. I LEFT A MESSAGE TELLING HIM I WANT TO CHANGE MY PLEA. RON HAS NOT RETURNED ANY OF THESE CALLS. I HAD NEXT TO NOTHING BUT NOW I HAVE A HOME. NOTHING FANCY, BUT SIMPLE COMFORT THAT I'VE BEEN WITHOUT SINCE CHILDHOOD. I CANNOT IMAGINE STARTING OVER AGAIN, AT MY AGE. I ASK YOU PLEASE APPROVE MY REQUEST. I THANK YOU FOR YOUR TIME.
