**GOVERNMENT’S MOTION FOR
WRIT OF HABEAS CORPUS AD PROSEQUENDUM**

The government respectfully requests this Court to order the Clerk to issue a Writ of Habeas Corpus Ad Prosequendum in the above-entitled case. The government requests that the Writ command the Warden of the Women’s Eastern Reception, Diagnostic and Correctional Center, to deliver to the custody of the United States Marshal, the defendant, BELINDA LEIGH HEASTAN (Inmate 314219), so that she may appear in the above-entitled case in accordance with the laws of the United States, and after having so appeared, to be returned to the aforementioned custody as directed by this Court. In support of this request, the United States avers the following:

I. SUGGESTIONS IN SUPPORT

1. Defendant is presently incarcerated at the Women’s Eastern Reception, Diagnostic and Correctional Center, 1101 E. Hwy. 54, Vandalia, Missouri 63382.
2. Defendant was charged in the Western District of Missouri by federal grand jury indictment with knowingly and intentionally combining, conspiring, confederating and agreeing others to distribute a mixture or substance containing a detectable amount of methamphetamine, on April 9, 2009. An arrest warrant was issued at that time. Another defendant was arrested and

released on bond. The defendant was scheduled for a plea hearing on October 12, 2010 when it was discovered she had been arrested and incarcerated by the State of Missouri.

3. Due to defendant's incarceration in Vandalia, Missouri, the defendant does not have a scheduled court appearance.

II. CONCLUSION

WHEREFORE, the government respectfully requests this Court order the Clerk to issue a Writ of Habeas Corpus Ad Prosequendum in the above entitled case.
