## **B. Agenda For Pretrial Conferences**

Counsel are instructed to be prepared to discuss the following issues at the pretrial conferences:

1. Anticipated questions of admissibility of evidence;
2. Any other questions of law on which the parties desire pretrial rulings;
3. Facts or circumstances requiring a larger than normal jury panel (more than 45);
4. Pending motions;
5. Estimated trial time;
6. Discovery problems;
7. Possible stipulations (**counsel should have proposed stipulations available for review and signature by the parties at the conference**);
8. Number of exhibits to be offered at trial;
9. Number of witnesses to be called at trial;
10. Changes of plea or dismissal of charges.

Unless given a special setting, each of these cases is set for trial on the joint criminal jury trial docket commencing **January 5, 2009**.

## **C. Pleas**

Regarding possible changes of plea, it is

ORDERED that counsel for a defendant who intends to change his/her plea from “not guilty” to “guilty” or “nolo contendere” shall immediately call the Courtroom Deputy of the assigned District Judge at the telephone numbers listed below so that a change of plea hearing can be set
