My name is Elnader A. Hale. I am the sister of Brice Hale. He is my baby brother but often times I listen to his advice and counsel as if he were the older one. My brother is an amazing man. I am very proud of him both as my brother and as a man.

My brother and I have the same father but we have always considered ourselves full brother and sister. He is a compassionate, kind, understanding, helpful, respectful, hard worker, self starter and role model. As a product of a single parent, (his mother raising he and his two brothers alone after our father passed when Brice was two) gave him a insight into parenting solo that most men do not take the time to understand and or do something about

My brother came up through the school of hard knocks that is to say he never had the best of anything as he was growing up, but he never complained or asked for more from his mother. He grew up without the benefit of a male role model. When others his age were becoming involved in gangs and other delinquent activity, he chose to become active in sports, (basketball). He initially could not play very well, but he spent countless hours simply bouncing the ball and throwing it until he became good at the game eventually becoming captain of his team. He played sports even though he had no ride to and from practice or to and from games, he "walked." He walked miles in the dark after playing games both away and at home because he wanted to make something of his life rather than be like his peers. He was not a quitter and his persistent paid off by his becoming the most valuable player on the team.

My brother went to college despite the fact that he had been discouraged by some not to. He graduated from Lincoln University and I could not have been prouder of him than if he were my son. He struggled through school with lack of funds for housing, food, clothing and books. He and God made it through those four years together.

I was helping my brother financially, emotionally and physically when he was in college. He wanted to help and felt bad taking help from me especially when I was having marital problems as well as a high risk pregnancy. He asked me about going into the armed services to which I was against, but he enlisted in the Marines so he could help with his finances. It was tough for him to attend school full time and be in the military but he did it. He received an honorable discharge from the military and took eventually took a civilian job.

After college, I invited my brother to come and live with me, but he opted to return to his mother's home even though his prospects of getting a job were dim. He returned home to his mother because his mother had been diagnosed with cancer and it was not known how long she would live. My brother put his life on hold. He alone took care of his mother from taking her to doctor's appointments, cooking, cleaning and making sure that she had taken her medications. When she became too ill to take care of herself, rather than going into hospice, my brother, alone, took care of his mother, he bathed her, he carried her to the bathroom, he took care of bills and did everything he could to make his mother last moments as best as he could. She passed while he was taking care of him. This loss affected him deeply. At this point in his life, I am sure he felt alone, but he knew he had me to rely on. He has consistently proven the naysayers wrong in being successful in all the endeavors he has attempted to do. I am proud of him.

My brother has taken his business degree and parlayed it into a myriad of jobs for other people within the community. He is looked up to by young men and women as well as his peers. He saw young men walking around without a job and hanging on the streets, so he created a law company and purchased lawn equipment and hired those young men to not only mow the lawns of property he then owned but also he found other lawns for them to mow. The ability of these youngsters to be able to work and earn money while learning how to be a young man was priceless.

My brother applied to Webster University in St Louis Missouri for their Business Master program and was accepted. He started his classes but chose to drop out when I needed surgery to one of my knees. He came to Kansas City Missouri to take care of me while I was healing. His care of my household chores, cooking, and laundry, taking care of my son and getting me back and forth to the doctor's appointment was priceless and so much appreciated. When I was well enough to ambulate on my own, he returned to his home.

My brother adopted a young man (I advised against it) who was destined to be in the streets or dead. He saw something in this young man, (Avian Kincaid) that I did not see or anyone. Avian was a youngster when my brother initially started to helping him out. He was in middle school that was a thirty minute car ride from his house and none of his family was concerned about him going to school. He lived with his mother and his mother allowed him to date older or adult women even having sexual relations in her house with her permission. My brother persuaded Avian that he was too young for that activity and began to point him in the

direction of activities suitable for a young man his age. Brice started to talk with Avian when he saw him playing football and noticed that he was good. He thought if he could get him hooked on football he could get him to become an active and productive student. My brother would get up early every school day morning and wake up Avian, then go to his house pick him up from home and take him to school. He would then pick him up after football practice and take him home. Many times Avian was hungry and Brice fed not only him but his entire family. Many times their utilities were turned off and my brother gave the mother money to get her utilities turned back on. When Avian needed shoes and clothes for school, my brother bought them. My brother was a leaning post and a guide for Avian and, but for, my brother Avian would not have entered high school. Avian graduated from High School with a GPA of 3.0. When my brother first became a big brother to Avian he was barely going to school and had straight "F's". No one believed in him and had told him he could not do it nor provided him the tools to make it, but my Brother. Avian was accepted to Kansas State University last year. He is the first of his family to graduate from high school and the first to attend college.

My brother has compassion for single mothers and the struggle that they have to conquer especially when they are young children in the home. He has been an active part in so many young men and women lives, not only emotional support but physically being there for them and letting them see what it means to be a man.

My brother is the apple of my son's eye. He has been such a help to me in rearing my son. My son just graduated from high school this year. He will be attending college. He has a great relationship with my brother and looks up to him.

I have had to have several surgeries and at each one including the emergency birth of my son, my brother has been at my bedside. He has taken off from work to come and take care of me when I had bilateral knee surgeries, when I had a hysterectomy and oral surgery. Although he has had his own life, he is selfless in that he willingly places his life on hold to come to my aid and rescue. I am scheduled to have bilateral total knee replacements and I once again need my brother to be by my side to help take care of me. He is the only family member that I have who can and willingly will lift me to ensure that I shower, bathroom breaks and he takes care of my incisions as well. While taking care of me he also took care of my son as well.

I now am disabled and unable to walk most of the time as both of my kneecaps have collapsed upon the joint causing terrible pain. I have to have four shots in my knees every three

months or when the pain becomes unbearable by Dr. Dugan in order to have some function of daily living. I need the surgery but will need my brother once again to assist me in the recovery process. What is amazing about my brother is that I never have to ask him to come and take care of me; he simply comes and does what I need to have done in order to get better.

My brother is a good man. He is a good and loyal friend. He is sensitive to the needs of his fellow man and woman. He is not only my brother but he is my best friend. We talk at least twice every day, but more often like five times. We not only play together, but we pray together. I depend heavily on him. He will give the shirt off of his back and then take the individual to the store and buy them a couple more to ensure they have clothing. He has made it his assignment to reach out a helping hand to anyone who is within his reach and he can help. It is not unusual to find Brice going out of his way to make sure that a neighbor gets a ride to work and back home from work. He is not afraid of getting his hands dirty or doing chores traditionally thought to be unmanly. If he can help he will do it or he will give it his best try at doing the job.

There is so much that I can say about my brother and his great attributes and talents. In spite of the times that I have not been fully supportive of him (i.e. becoming a mentor, big brother for at risk males, entering the military while attending college), his decisions that he has made were good ones that made him a better man and person who could and has reached back and helped those who are less fortunate than himself and who truly need help but no one has been there to help them. Brice is my "Knight in Shining Armor" and I know he has been a lifeline for so many other people a lot of whom I have met and heard their testimonies as to what a great person my brother has been to them.

He truly a good citizen and a great assess to his friends, family, and community. He is one of a kind and I appreciate and love him very much.
