MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

COMES NOW Defendant, Theodore S. Wiggins, by and through his attorney of record, and pursuant to 28 U.S.C. § 1915(a)(1), and moves this Honorable Court to make and enter its Order, granting Defendant leave of Court to proceed in forma pauperis upon appeal of his conviction in the above captioned case. The grounds for Defendant's request will be set forth in the subsequent numbered paragraphs, to-wit:

- 1. Defendant is a poor person, without the means or funds to prosecute an appeal of his conviction in the above captioned case. - 2. - 4. The ends of justice will best be served by the Court granting the relief sought in this request.
