AFFIDAVIT

I, Mike Miller, being duly sworn, hereby depose and say:

1. I have been a Police Officer with the Kansas City Missouri Police Department for approximately 15 years. I have been working as a detective in the narcotics division for 10 years. I have reviewed the reports in the following investigation and have direct knowledge of the results of this investigation.

2. On May 9, 2010, at 2039 hours, Police Officers Grinik and Eickmann with the Kansas City, Missouri Police Department were conducting traffic enforcement activity at a stop sign at 41st Street and Chestnut. The officers observed a white Dodge pick-up truck commit a stop sign violation. The white Dodge pick-up had a Missouri license plate, number 4DG-743. The officers initiated a traffic stop on the vehicle. The driver of the vehicle, who was later identified as Naricco T. Scott, (B/M, DOB: 01-05-1982), refused to stop. Scott fled from the officers at a high rate of speed. The officers observed Scott fail to stop for a second stop sign and he then turned the headlights off and continued to drive at a high rate of speed away from the officers. The officers briefly lost sight of the vehicle and they began an area canvass to attempt to re-locate Scott and the vehicle.

3. While conducting the area canvas, the dispatcher notified the officers of a 911 call from a residence at 4414 Askew. The caller stated that a black male had parked a Dodge pick-up truck in the caller's driveway. The caller further stated that the truck's driver was attempting to gain entry into the caller's residence. The caller stated that the black male driver told him that he was running from the police and that he wanted to enter the caller's house. The officers then responded to 4414 Askew and observed Scott walking on the east side of 44th Street in front of 4401 Askew. The officers attempted to make contact with Scott who fled on foot. Officer Grinik chased Scott on foot and eventually took him into custody at the rear of 4401 Askew. A search of Scott incident to arrest revealed the keys to the white Dodge pick-up truck, (license 4DG-743, Missouri), that was parked in the driveway of 4414 Askew.

4. Officers Rains and Madera contacted the 911 caller at 4414 Askew. The party stated he heard the Dodge pick up truck pull into his driveway. The caller then stated that a black male carrying a purple Crown Royal bag knocked on his door and offered money to be able to hide from the police in the caller's house. Officers searched the area in front of the house at 4401 Askew where they had first seen Scott on foot. The officers located a purple crown Royal bag lying on the ground next to the fence at 4401 Askew. The officers recovered approximately 126 grams of a beige rock like substance, believed to be cocaine base, a digital scale and 9 live rounds of 9mm ammunition from the purple Crown Royal bag. Sgt. Bergquist located an unknown handgun on the roof of 4401 Askew while illuminating the roof with his flashlight. A consent to search was obtained from the owner of 4401 Askew. Officers retrieved the handgun

from the roof of the residence. The handgun was identified as a Glock 22, 40 caliber handgun containing one live round in the chamber and 10 lives rounds in the magazine.

5. Officer Grinik inventoried the white Dodge pick-up truck with license 4DG-743, that was parked in front of 4414 Askew. Officer Grinik located approximately 7 grams of a green leafy substance and approximately 24 grams of a beige rock like substance, believed to be cocaine base from the middle console. The substances believed to be cocaine base that was recovered from the purple Crown Royal bag and from the Dodge pick up truck were field tested showing a positive result for the presence of cocaine. Based upon my experience in narcotics investigations, I believe that the cocaine base recovered from the Quantity, which exceeds an amount possessed for personal use, and its proximity to the digital scale which is commonly used by narcotics dealers.

6. A check of Scott's criminal history shows Scott to have an active felony warrant for Resisting Arrest. Scott shows to be a convicted felon for Tampering Motor Vehicle and Possession of a Controlled Substance via Jackson County, Missouri. Scott is currently on Jackson County, Missouri Pre-trial release for Possession of a Controlled Substance.
