title, or imprisoned not more than three years or
both."

"(Title 31 Subtitle III, Chapter 37, Subchapter III)"

"§ 3729. False claims(a) Liability for Certain Acts.—Any
person who—(1) knowingly presents, or causes to be
presented, to an officer or employee of the
United States Government or a member of the
Armed Forces of the United States a false or
fraudulent claim for payment or approval; (2) knowingly
makes, uses, or causes to be made or used, a false
record or statement to get a false or fraudulent
claim paid or approved by the Government; (3) conspires
to defraud the Government by getting a false or
fraudulent claim allowed or paid."

The clerk of court has violated his/her job description
by adding back dated data in clear fraud on the
court. Therefore by these facts with proof and
evidence that this case must be dismissed with
prejudice against defendant in error immediately.

In the doctrine of (Lex Loci) or (The Law of
The Place) determines that standard of conduct and
governs as to the matters within the right of action.
(Gray VS. Blight, 112 F.2d 696).
