Dear Fernando:

I am writing you in response to your recent offer by way of indictment as released by you on or about September 21, 2011 in the trust matter as referenced above. **YOUR OFFER TO RELINQUISH MY POSITION AS BENEFICIARY TO CASE NO. 4:11-cr-00223-ODS, AND TO ACCEPT THE ROLE OF TRUSTEE IS DECLINED.** As you are an experienced public trustee, I have the utmost confidence in your ability to protect the interests of the trust and this beneficiary and to ensure that the executor, THE UNITED STATES OF AMERICA, Daniel Morton Nelson and Thomas M. You don't expect me to challenge the prior superior claim of my creator and make a false claim to the contrary do you?
